State's SB/DVBE Goals

- Requires state agencies to award at least **25%** of their annual contracting dollars to certified Small Business
- MVC Section 999 requires agencies to award at least **3%** to certified Disabled Veteran Business Enterprises (DVBE)

Small Business Eligibility Requirements

- To be eligible for SB certification, the business must meet the following criteria:
 - Must be independently owned and operated;
 - Cannot be dominant in the field of operation;
 - Must have its principal office located in California;

Small Business Eligibility Requirements

- The business must also:
 - Have its owners (or officers in the case of a corporation) domiciled in California;
 - And, together with the affiliates, be either:
 - a business with 100 or fewer employees, and have an average annual gross receipts of \$14 million or less over the previous 3 tax years, *or*
 - a manufacturer with 100 or fewer employees

DVBE Definition

- For DVBE certification purposes, a “disabled veteran” is a veteran of the U.S. military, naval, or air service; and has a service connected disability of at least 10% or more as certified by the United States Department of Veteran Affairs and must be domiciled in the State of California.

DVBE Eligibility Requirements

- Most DVBEs can also be certified SBs
- To be eligible for DVBE certification, the business must meet the following criteria:
 - Be at least 51% owned by one or more disabled veterans (defined on next slide)
 - Limited Liability Companies (LLCs) must be wholly owned by one or more disabled veterans

DVBE Eligibility Requirements

- Daily business operations must be managed and controlled by one or more disabled veterans. The disabled veteran(s) who manages and controls the business is not required to be the disabled veteran business owner(s)
- The home office must be located in the United States. The home office cannot be a branch or subsidiary of a foreign corporation, foreign firm, or other foreign based business.

Benefits of Certification

- Increases opportunities for the SB & DVBE community and stimulates the economy
- Levels the playing field when competing for state contracts & purchases
- 5% Bid Preference for Small Business
- The State may offer up to a 5% incentive to DVBE's in the formal bid process

Benefits of Certification

- As a California certified SB/DVBE, your firm is added to the Department of General Services' certified firm database
- State agencies use this database to find suppliers

SB/DVBE Option

- Certified SB *or* DVBE
- Goods, Services, & IT goods and services - \$5,000.01 to \$249,999.99
- Public Works - \$5,000.01 to \$270,000.00
- At least two price quotes (2 SBs or 2 DVBEs)
- Market your company to state agencies (see Step 5)
- Authorized by Govt Code 14838.5

SB/DVBE First Policy

- Certified SB or DVBE
- Goods, Services, & IT goods and services - \$0.00 to \$249,999.99
- Public Works - \$0.00 to \$270,000.00
- At least two price quotes (2 SBs or 2 DVBEs)
- DGS, FTB, Cal Vet, Military Department, Department of Public Health, and DCA have First Policy in place







Register to do business with the State*

Step 1: Log on to www.eprocure.dgs.ca.gov—In the *Access eProcurement (eP)* box click on *Register* to create a new eP supplier profile.

Step 2: Your Information—Enter your *Main Contact* and *Company Information*, including *Time Zone*. Create your *User Name* and *Password*. Write these down and keep them in a secure location. Click *Next Step*. (Do **not** enter DUNS, FEIN, SSN.)

Step 3: Goods and Services—Select your *Primary Industry* and select at least three keywords. A screen will appear on the right side of the page. Check the appropriate keywords. Click *Search*. Click *Done Reviewing*. Select the appropriate NIGP codes and *Save*. Under *Where do you do business* select *California Only*. UNCHECK *Include BidSync Links PLUS Bids (Recommended)*—this is BidSync's fee-based service. Click *Next Step*.

Step 4: Supplier Registration Complete—Congratulations, you have successfully registered with Bidsync. You will receive an email within one business day informing you that your account has been activated. Or you may call BidSync Support at 1-800-990-9339 to activate your account immediately.

- Have attachment/brochure with supplier id number included (business cards and emails, too!)

- Send attachment/brochure updates every 3 to 4 months via email
- CHECK GRAMMAR and SPELLING!
- Don't overdo the attachments!
- Acknowledge any contact with a courteous reply
- Provide technical data to support claims, if needed
- Use business resources to help you perfect your marketing techniques-it's a worthwhile investment!
- **To Get the Contract, make the contact!**





The Department of Water Resources achieved 2011-12 SB/DVBE Results – SB (29%, up 7% from last year); DVBE (9%, up 5% from last year) This is due to collaborative efforts between the advocate and staff that have resulted in a

consistent, continual improvement to the SB/DVBE program performance; development, implementation, and the creation of innovative processes and procedures, templates, workshops, and training; our winner has created stronger bid language and more focused outreach and education to acquire SB awards exceeding \$20 million; program staff, buyers and contract analyst routinely contact the advocate for assistance early in the process.

The department has entered a new "normal" with regard to SB and DVBE participation - that of posting greater than 20% SB and 3% DVBE as opposed to the mid-teen SB percentages and less than 3% it was achieving prior to FY 08/09. In the last four years the department exceeded mandated DVBE participation each year. Small Business has twice achieved 22% and twice exceeded 25%, the most recently in FY 11/12.

This department consistently spends over \$45 million dollars each year in the SB community. Over the last five years the Department has spent \$309.1 million dollars in the small business sector and \$64.4 million in the DVBE community.

Leveling the Playing Field (Updating Your Profile) eProcurement



These instructions are to accompany the Power Point "Leveling the Playing Field". Make a copy of the Power Point presentation, number the slides (1) to (61), and follow these instructions. Word/Excel 2010 versions used.

- **CLICK** Generate Export List (CSV Format) located at the top right of the page (8)
- **OPEN** , **SAVE** to desktop (9) (10)

How to update your keywords:

- **HIGHLIGHT ENTIRE** Column R, **COPY** and **PASTE** into a new Word document. You are limited to 255 characters: eliminate words that don't belong, don't repeat words, don't use periods, commas, extraneous words like: and, the, no, &'s. Your profile should look like this: word space word space, etc. (11) (12) (13)
- **TOOLS, WORD COUNT** ((Characters (with spaces) cannot exceed 255 characters) (14) (15)
- **TOOLS, SPELLING AND GRAMMAR, SPELL CHECK** (16) (17)
- **SAVE** Word document for profile (18)

How to update your UNSPSC Classification codes:

- **GO BACK** to the Generate Export List and **HIGHLIGHT ENTIRE** Column Q, **COPY** and **PASTE** into a new Excel spreadsheet in Column A (19) (20) (21) (22)
- **DELETE** the entire line 1 (UNSPSC and _NAICS_CODES) (23) (24)
- **HIGHLIGHT ENTIRE** Column A (25) (26) (27)
- **DATA, TEXT TO COLUMNS, DELIMITED, NEXT, UNCHECK TAB, CHECK SEMICOLON, NEXT, FINISH** (This will put classifications codes into separate columns.) (26) (27) (28) (29) (30) (31)

At this point, if you only have 30 or less UNSPSC codes, save and print your pages. Manually delete any duplicate UNSPSC codes on your printout and skip to "How to update your profile" (51), otherwise continue.

- **HIGHLIGHT A1 ONLY** (32)
- **VIEW, MACROS, RECORD MACRO, OK** (33) (34) (35) (36)
- **VIEW, MACROS, VIEW MACROS HIGHLIGHT** Macro 1, **EDIT, HIGHLIGHT** the script and **DELETE** it from the page, **COPY** "JustDolt" Macro text from macro at the bottom of these instructions, **PASTE** on deleted script page, **CLOSE** page, **CLICK RUN, RUN SUB/USER FORM**. (Computer is now creating a list of UNSPSC classification codes) (37) (38) (39) (40) (41) (42) (43)
- **CLICK** the X (Excel Icon on the top left side of page under File) (44) (45) *Please wait....* You should have a list of UNSPSC classification codes in ascending order after a few minutes.
- **SAVE** and **PRINT** [You are **NOT** limited to the number of codes; however, make sure that you use only the applicable ones! If your list is long, you may want to save paper and cut/paste the document and make it look like Slide 46.] (46) (47)




