

# **City Council Highlights**

#### December 4, 2018

#### APPROVAL OF MEASURE M2 EXPENDITURE REPORT (Agenda Item No. 6)

Measure M2 is a renewed ½ cent sales tax approved by voters in 2006 to fund transportation improvement projects throughout the County. Each year the City of Lake Forest reports its expenditures using M2 funds, as required by the legislation. In Fiscal Year 2017-18, the City spent \$2,114,357 on street repaving and slurry seal projects, \$177,593 on the Water Quality Program, \$93,041 on the Senior Mobility Program, and \$175,266 on the Project V Community Based transit/Circulators Program. Upon reviewing the expenditures and finding them to be in compliance, the City Council voted unanimously to approve the report and authorized staff to forward information to the Orange County Transportation Authority, as required by law.

#### RESOLUTION CERTIFYING THE NOVEMBER 6, 2018 ELECTION (Agenda Item No. 16)

The General Municipal Election was held on Tuesday, November 6. Neeki Moatazedi received 4,194 votes in District 2, Scott Voigts received 4,206 votes in District 3, and Mark Tettemer received 3,333 votes in District 4. A resolution was adopted certifying these results. The resolution also cited the passage of Measure S, the City's term limit measure, which took effect immediately upon adoption of the resolution and applies prospectively beginning with Council terms commencing with the November, 2018 election.

#### SELECTION OF MAYOR AND MAYOR PRO TEM FOR THE ENSUING YEAR (Agenda Item No. 21)

The City Council annually selects one of its members to serve as Mayor and Mayor Pro Tem in December for the coming 12 months. Mark Tettemer was selected to serve as Mayor in 2019 and Neeki Moatazedi was selected to serve as Mayor Pro Tem.

#### ANNUAL "LAKE FOREST LIGHTS" HOLIDAY LIGHTING CONTEST (Agenda Item No. 2)

The "Lake Forest Lights" holiday lighting contest was launched in 2017 to allow residents to share photos of their decorated homes on Facebook, fostering community pride and interaction through the City's Facebook page. The entries also allowed the City to compile a map of well decorated homes for residents and visitors to tour during the holidays. The contest was promoted on the City's social media channels, The Leaflet, and the City's e-Newsletter. Entrants uploaded their photographs to the City's Facebook page and the winner was determined by the number of "Likes" each photo received. The City received nine entries and more than 330 "Likes" on social media. All entries were imaginative and captured the spirit of the season, including "Santa's Workshop," a home with 20 Christmas trees and a musical Christmas light show. The City Council recognized the winner of the contest with the most "Likes," Mr. Scott Silver, for his "Let it Snow, Silver Style," entry and presented him with a yard sign proclaiming him the winner of the 2018 "Lake Forest Lights" contest.

#### 2019 LEGISLATIVE PLATFORM (Agenda Item No. 16)

City Council adopted a Legislative Platform to provide broad policy direction to staff on local, state, and federal legislation. This information is used by the City Manager's Office to administer the City's legislative advocacy program, which includes evaluating legislative proposals and providing recommendations for the City Council. The Legislative Platform also provides staff with direction to take more immediate action in the event it is necessary that staff respond to a legislative proposal prior to City Council direction.
